## **Refer and Earn - Terms & Conditions**

- This Scheme is applicable for all existing Maitra Commodities customers.
- The referrer must be a Client at Maitra Commodities Pvt Ltd and must have an active trading account for earning the referral bonus. If the referrer account is In-active the referrer will not be eligible for any referral bonus.
- The client/referrer will get 10% of brokerage amount on each eligible account referred.
- There is a limit of 10 referral for each customer of Maitra Commodities.
  - For Eg: If client has referred 10 eligible accounts, client will get 10% of brokerage amount generated from each of 10 clients if all 10 of them open their account with Maitra Commodities.
- In case of 10 referral, only 3 of them successfully open the account with Maitra commodities and trade, then client will get 3 client's 10% brokerage amount.

- Account will be activated in Equity cash, Futures & Options and MCXFO by default unless specified specifically during the account opening.
- If a person is been referred by more than 1 person, then the person who has referred 1st will be considered.
- Post receiving the referral, we will only contact to those referrals who are not registered under DNC for assistance on account opening process.
